

D. ADMINISTRATION

3. PROPOSED STATEMENT ON DENIAL OF LICENSURE.  
It was moved and seconded to accept the policy statement on denial of licensure. MOTION CARRIED.
4. REPORT OF CONTINUING EDUCATION CONSULTANT  
Ms. Burress read the report prepared by Carole Mentzer, R.N. 103 CE courses were approved from 9/4/86 through 11/11/86. 97 submitted by Nevada CE providers; 6 by out of state providers. By consensus the Board ratified the action of the staff in approving these CE courses.
5. REPORT OF TASK FORCE TO SELECT ASSISTANT EXECUTIVE DIRECTOR.  
It was moved and seconded to reaffirm the decision of the Nevada State Board of Nursing to fill the previously established Assistant Executive Director position. The justification for re-filling the position at this time is documented by (1) Increased work load in the office, and (2) The need to help the Executive Director implement the Goals & Objectives established by the Board to meet the requirements of NRS 632 to protect the public health, safety and welfare when nursing service is provided. 6. LETTER FROM PHYLLIS MCKINNON, RN AND LORRAINE KOSSOL, RN, REGARDING REGISTERED NURSES DISCONTINUING SURGICAL DRAINS.  
It was moved and seconded that as long as the requirements of NAC 632.225 are met, the removal of mediastinal drainage tubes be recognized as within the scope of registered professional nursing practice. MOTION CARRIED.
7. LETTER FROM BARBARA WAGGONER, RN, REGARDING NURSES ADMINISTERING BLOOD AND CHEMOTHERAPY IN THE HOME SETTING.  
Mrs. Waggoner of Nevada Home Health Services in Elko, was present and spoke to the issue.  
It was moved and seconded that the administration of blood and blood products is in the scope of practice of an R.N. MOTION CARRIED.  
It was moved and seconded that as long as the requirements of NAC 632.225 are met, that the administration of chemotherapy is within the scope of R.N. practice. MOTION CARRIED.
8. REQUEST FOR ENUCLEATION TO BE CONSIDERED TO BE WITHIN THE SCOPE OF NURSING PRACTICE.  
It was moved and seconded to table this item until the June 1987 meeting. MOTION CARRIED.
- 8.5 CONSIDERATION AND ACTION REGARDING LPN'S PASSING NG TUBES BEING WITHIN THEIR SCOPE OF PRACTICE.  
Janine Sawaya, Director of Nursing at Sunrise Hospital, was present and presented 13 letters from directors of nursing and administrators in support of reconsidering the decision on placement of NG tubes by LPN's made by the Board at the June 1986 meeting.

Ms. Sawaya and Pegge Bell, Coordinator-Nursing, Clark County Community College, testified that they would like to see a training program for inserting NG tubes in the community colleges, and that the schools had all agreed to offer this as an 8-hour continuing education course.

It was moved and seconded to accept the wording of the proposed Naso-Gastric/Oral-Gastric Tube Insertion regulation. MOTION CARRIED.

9. SHALIN BOWLER, REQUEST TO TAKE NCLEX AFTER GRADUATION.
