E. EDUCATION

- 1. Review, discussion and action regarding Carrington College (Apollo) Las Vegas, progress toward full approval as nursing school (Carrington detailed response to Oasis consulting report and current faculty and clinical placements.): Dr. Colosimo read a letter from Dr. Lois Hine of Carrington College which informed the Board that the Las Vegas campus will be closing their nursing program in 2012. The letter gave April and March as closing months and R. Colosimo agreed to get clarification on which month will be their final month. At the May 2011 Board meeting, Dr. Hine will present a detailed plan on how the program will provide for the 49 students who will be graduating in March of 2012. The 25 general education students they currently have enrolled will receive a full refund and a copy of their transcripts. K. Espinosa asked how the Board will disseminate this news. D. Scott stated that because this is a new situation for the Board we will consult and create a plan. K. Espinosa expressed much concern for the students and all board members agreed that it is imperative the students' transition is as smooth as possible. It was moved and seconded the Board accept notification of school closure and request a complete report at the May 2011 Board meeting. MOTION CARRIED.
- 2. Review and discussion regarding calendar year 2010 G-4 NCLEX first time pass rates and trend for the first quarter of 2011: R. Colosimo advised the Board that the projections she gave before the official G-4 came out were accurate. Touro University had a 48 % pass rate for 2010 and was placed on conditional approval based on NAC 632.630. University of Southern Nevada had a 70% pass rate and is on the agenda at this meeting to present a plan for improvement. National University had a 40% pass rate and will be presenting a more detailed action plan at this meeting as well. R. Colosimo stated the trend for the first quarter of 2011 showed all the Nevada System of Higher Education (NSHE) schools are above 90%. National University had two candidates take and fail so far this quarter. T. Smyer asked how Nevada ranked nationally and R. Colosimo agreed to bring that information to the May 2011 Board meeting.
- 3. Review, discussion and action regarding Carrington College (Apollo) Reno, 18-month survey: R. Colosimo introduced Ms. Merchant and Ms. Gonzales from Carrington College, Reno. R. Colosimo stated she completed a joint visit with the National League for Nursing Accrediting Commission (NLNAC) for Carrington College's nursing program. Ms. Merchant informed the Board that during her exit interview with NLNAC it was indicated that Carrington College would receive five-year accreditation. Additionally, Ms. Merchant informed the Board that 19 out of 19 students passed the NCLEX the first time taken. D. Begley expressed her congratulations. T. Smyer asked R. Colosimo where in the process of full approval Carrington College is and R. Colosimo responded that they were right on track and should be able to apply for full approval next January, which is two years after the first class graduates. It was moved and seconded the Board approve continued provisional status, the survey be accepted and a resurvey of Carrington College's skills lab occur in two months. MOTION CARRIED.
- 4. Review, discussion and action on the status of administration at ITT Technical Institute nursing program: R. Colosimo informed the Board that Dr. Schuber, the current director of the program, is on medical leave from ITT Technical Institute. This message resulted in a meeting with Dean Sackey and Campus Director Nimmer with the purpose of informing them of the requirement to keep the NSBN informed of any changes in leadership. Dr. Colosimo reminded them of the requirements for the program director based on regulation. Dr. McHaney stated she would be the interim director, Dr. Schuber would not be returning

and a search to fill the vacant position will begin. An additional 2 full-time faculty members have been hired and 4 ½ faculty members are expected to be employed before the next cohort is admitted. D. Begley asked specifically how long Dr. McHaney would be on campus and Dr. McHaney replied that she would remain on campus until a replacement was found and oriented. T. Smyer asked for additional information about clinical placements for the students. It was moved and seconded the Board direct Dr. McHaney as interim administrator for ITT Technical Institute nursing program to provide a status report at the May 2011 Board meeting. MOTION CARRIED.

5. Review, discussion and action on the correction plan regarding University of Southern Nevada's 2010 NCLEX performance below 80%: Dr. Mabel Smith and Mary Chalfant presented the plan of correction to the Board. D. Begley stated she thought the plan was light on details and data. K. Espinosa expressed concerns as a chief nursing officer regarding the remediation of students because new graduates must be well prepared for the difficult hospital environment. R. Carruthers expressed concern that the program was not on sound footing yet. D. Scott clarified that in the curriculum all students have a 4.0 grade point average because they are required to pass at 90% and their NCLEX pass rate seemed inconsistent with those grades. It was moved and seconded the Board accept the plan of correction and directed Dr. Colosimo request a more detailed correction plan. MOTION CARRIED.

Colosimo explained the changes made by Oxman College and stated there were still concerns about preceptorship, faculty and clinical placements and their questionable eligibility for institutional accreditation acceptable to NLNAC. R. Colosimo also shared that the Commission on Postsecondary Education (CPE) stated Oxman College's license was suspended as the bond is insufficient and they may have their CPE license revoked in May 2011 because of this noncompliance. D. Begley referred to Oxman College's application and identified that many areas referred to the state of California and the report needs to be proof read. T. Smyer requested information on the preceptorship throughout the curriculum and T. Cline responded that it was being worked out. T. Smyer asked how they would insure competence of students in preceptorship throughout the curriculum and T. Cline stated they would make sure the students were safe. D. Begley asked for additional information about Oxman College and R. Colosimo provided that this would be their first associate degree program, they are from California and have a LVN school and although R. Colosimo did not have their 2010 pass rate, she shared their 2009 pass rate, which was 70%. Mr. Dvorkin stated he was in the process of opening programs in New Mexico and California and that his government relations contact was very helpful. Mr. Dvorkin expressed his frustrations with Nevada's application process and R. Colosimo reiterated our requirements and gave examples of how all Nevada schools are required to comply. It was moved and seconded the Board not accept the application for candidate for provisional approval for an associate degree program until appropriate institutional accreditation for NLNAC application is in place. MOTION CARRIED.

7. Review, discussion and action regarding the University of Southern Nevada accelerated BSN program: R. Colosimo presented this agenda item. Dr. Smith stated she was glad to allay any rumors and clarified that this program is completely a University of Southern Nevada (USN) program. T. Smyer asked if it were taught by USN faculty and if USN developed the online teaching tools. Dr. Smith confirmed that all aspects of the program where completed by USN staff. Dr. Smith stated that the goals for the program of 4 cohorts of 48 a year were very ambitious and they have already decided they do not have sufficient

- clinical placements to admit the next cohort. S. Halley explained that accelerating a curriculum that is already in need of being modified is a concern for her for the students. M. Chalfant stated she would always make sure that there were clinical placements for students. The Board accepted the more complete information on the program and alerted Dr. Smith that they would want separate statistics on each program.
- 8. Review, discussion and action regarding National University's detailed action plan for meeting Board requirements for full approval: Dr. Carver and Dr. McHugh stated they were very concerned about their NCLEX scores and thought the action plan would improve student performance over time. T. Smyer asked about the timeline for full approval for National University and R. Colosimo stated that in October/November 2011, National University would have to apply for an extension of provisional approval. T. Smyer stated she was not inclined to vote for an extension and expressed concern about schools being ready to open for students. T. Smyer clarified with Dr. Carver that the first class graduated on October 5, 2009. Dr. McHugh stated she was sure her plan would work giving examples of her orientation to nursing and although National University students are unhappy with the changes, the minimum passing percentage has been raised from 73% to 76 %. R. Colosimo expressed her concern about the focus on remediation and not curriculum. R. Colosimo reminded the Board that the previous year National University had to be directed to hire 3 full time faculty members. K. Espinosa again expressed her concern from a chief nursing officer perspective that students need to be well prepared because the hospital environment is difficult. It was moved and seconded the Board accept the plan but with caution that improvements need to be happening quickly for students. MOTION CARRIED.
- 9. Review and discussion of annual reports for the fully approved nursing schools: University of Nevada, Reno; University of Nevada, Las Vegas; Great Basin College; Western Nevada College; College of Southern Nevada; Truckee Meadows Community College; Nevada State College; Touro University and University of Southern Nevada. It was moved and seconded to continue this agenda item to the May 2011 Board meeting. MOTION CARRIED.
- 10. Review, discussion and action regarding Kaplan College proposed curriculum change for the associate degree program: Dr. Cylke announced their NLNAC site survey had gone well and they anticipate five-year accreditation. Mr. Dillman announced the shade for the outside student lounge area would be complete the week of March 14, 2011. R. Colosimo presented the Education Advisory Committee's concerns with the proposed curriculum change, which had been approved for candidacy last year but has not had a site visit. D. Begley reminded Dr. Cylke that the materials needed to be in to the NSBN in a timely fashion. R. Carruthers supported the same pharmacology course for both LPN and generic students. It was moved and seconded the Board accept the requested curriculum change for the associate degree program, which is in candidacy stage for provisional approval. MOTION CARRIED.
- 11. Review, discussion and action regarding the appointment to the Education Advisory Committee: It was moved and seconded the Board approve Kris Miller, RN05832 as a member of the EAC Committee. MOTION CARRIED.
