**Adamayan, Armen, RN47526:** Agreement for Probation for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (16) failing to properly document controlled substances, and (27) customary standards of nursing practice.

**Avila, Fiona, RN46954:** Suspended for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.
