**Adams, Brenda, CNA021643:** Agreement for Reprimand, Fine of \$50, and Continuing Education for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Bowers, Chrystal, CNA021569:** Renewal application denied by the Board for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.
