Abebe, Eskdar, CNA026288: Order of Reprimand, Fine of \$100 and classes for violation of violating NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (22) patient abandonment.

Application denied for violation of NRS 632.320 (1)(b) criminal conviction, and (1)(e) controlled substances and/or alcohol.

unprofessional conduct, and NAC 632.890 (24) failing to collaborate with health care team, and (34) neglecting a patient.
