Atwell, Albert, CNA applicant:

Application denied for violation of NRS 632.320 (1)(b) criminal conviction.

Becker, Kathleen, RN19805: Agreement for Probation for violation of NRS 632.320 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, and NAC 632.890 (27) customary standards of practice, (28) causing harm to a patient, and (33) abuse of a patient.

Bermudez, Frances, LPN11419:

Agreement for Reprimand and classes for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (2) practicing beyond scope, (27) customary standards of practice, and (28) causing harm to a patient.

Busch, Karen, LPN13339: Order of reprimand, fine of \$200, classes and hearing costs for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

Pearson, Kimberley, RN63586: License revoked for violation of NRS 632.320 (1)(e) controlled substances and/or alcohol, and (1)(o) failing to comply with Board order.

May not apply for reinstatement for five (5) years.

Pierce, Barbara, CNA012292: Renewal application denied for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

Raniero, Kathy, RN57806: License revoked for violation of NRS 632.320 (1)(a) fraudulent application, and (1)(m) action in another state. May not apply for reinstatement for one (1) year.

Real, Victoria, RN34998: Agreement for Fine of \$600 for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (37) practicing without an active license.

Sunnanon, Marissa, RN64945: Order of reprimand, fine of \$500, and classes for violation of NRS 632.320 (1)(a) fraudulent application, and (1)(m) action in another state.

Tangonan, Theresa, RN47033: Agreement for Fine of \$400 for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (37) practicing without an active license.

Wasson, Laura, RN65436: Agreement for Reprimand and Fine \$1,100 for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (37) practicing without an active license.
