Agbenou, Natacha, CNA023090: Renewal application denied for violation of NRS 632.320(1)(g) unprofessional conduct, and NAC 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

Algre, Emeltri, LPN13634: Agreement for Probation for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (20) inaccurate recording, falsifying, and (39) pattern of conduct, and (40) medication errors.

Almogela, Marnell, LPN10516: Agreement for Reprimand, Fine of \$1,300 and classes for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (37) practicing without an active license.

Cadle, Kami, CNA015808: Voluntary Surrender of Certificate in Lieu of Other Disciplinary Action for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (9) impaired practice, and (10) positive drug screen on duty.

controlled substances, and (27) customary standards of practice.
