## **Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of September 27, 2013 through November 8, 2013**

**Axelson, Janet, LPN10773:** Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.320 (1)(g) unprofessional conduct, and NAC 632.890 (10) positive drug screen on duty, and (27) customary standards of practice.
