**Basgall, Oneida, RN31709:** Order for Reprimand, fine of \$200 and classes for violation of NRS 632.320 (1)(g) unprofessional conduct, NRS 632.415 unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Blankenship, Charles, RN35715:** Order of Probation for violation of NRS 632.320 (1)(b) criminal convictions, and (1)(m) action in another state.

**Brown, Tiffany, CNA applicant:** Application denied for violation of NRS 632.320 (1)(b) criminal.

**Williams, Donna, CNA023516:** Agreement for Reprimand, Fine of \$50, and classes for violation of NRS 632.320 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.
