Each state has an action coalition (AC) comprised of various stakeholders. The goal of the AC is to implement the 8 Institute of Medicine (IOM) recommendations: Remove scope-of-practice barriers. Expand opportunities for nurses to lead and diffuse collaborative improvement efforts. Implement nurse residency programs. Increase the proportion of nurses with a baccalaureate degree to 80 percent by 2020. Double the number of nurses with a doctorate by 2020. Ensure that nurses engage in lifelong learning. Prepare and enable nurses to lead change to advance health. Build an infrastructure for the collection and analysis of interprofessional health care workforce data. The Nevada Action Coalition (NAC) and Nevada System of Higher Education (NSHE) partnered and received a grant from the Future of Nursing campaign. The grant goal it to implement two IOM recommendations. Therefore, it is called a State Implementation | |
