**Barlow, Maurice, CNA022949:** Agreement for Probation for violation of NRS 632.320 (1)(o) failing to comply with a Board order.

**Bartley, Beverly, CNA020736:** Renewal application denied for violation of NRS 632.320 (1)(b) criminal conviction.
