Aquino, Teresita, LPN13841: Agreement for Fine of \$50 for violation of NRS 632.320 (1)(g) unprofessional conduct, NRS 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

Baker, Esther, LPN16583: License revoked, may not apply for reinstatement for two years for violation of NRS 632.320 (1)(m) action in another state.
