1. Report from the January 2016 Board meeting: C. Dinauer reported the highlights from the January 2016 meeting. C. Dinauer stated that the pending Education, LPN, and APRN Regulations were accepted at the meeting.
2. Review, discussion, and action re: The role of the EMS-RN in the non-prehospital setting. D. Horvath from University Medical Center brought forward the question of the role of the EMS-RN in the non-prehospital setting and provided a history of the practice at UMC. F. Olmstead explained the law regarding EMS-RNs. The Committee concluded that the question is no longer regarding EMS-RNs but regarding the scope of practice of an RN. The Committee recommended that UMC find further data and evidence to support increasing the scope of practice of an RN when participating on a rapid response team.
