## **Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of January 27, 2016, through March 31, 2016**

**Broo, Erin, CNA032968:** Certificate Revoked, may not apply for reinstatement for two (2) years for violation of NRS 632.320 (1)(o) failing to comply with a Board order.

**Cagle, Gerald, RN79529:** License Revoked, may not apply for reinstatement for twenty (20) years for violation of NRS 632.320 (1)(m) action in another state.

**Crawford, Jennifer, RN62192:** Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.320 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, and NAC 632.890 (18) diversion of equipment or drugs.

**Dornbusch, John, RN17840:** License Revoked, may not apply for reinstatement for twenty (20) years for violation of NRS 632.320 (1)(m) action in another state and (1)(n) deceive, defraud, or endanger a patient.
