**Anderson, Linda, RN28558**

Found guilty for violation of NRS 632.320 (7) unprofessional conduct and NAC 632.890 (18) diversion. The Board ordered disciplinary probation for three years.

**Beland, Lori, RN30382**

Agreement for Fine for violation of NAC 632.890 (36) practicing without a license.

**Blackburn, Linda, CNA9131**

Found guilty of violation of NRS 632.320 (14) violation of a Board order based on the contents in the Stipulation of Facts received into evidence. Certificate to be suspended until respondent meets the requirements of her previous Board order.

**Cahee, Jacqueline, CNA6699**

Agreement for Reprimand for violation of NAC 632.890 (2) practicing beyond scope.

**Carter, Irene, RN21124**

Agreement for Reprimand and Fine in the amount of \$200 for violation of NAC 632.890 (36) practicing without a license.

**Davis, Sheila, LPN Applicant**

Application for licensure denied based on violation of NRS 632.320 (2) convictions.

**Hughes, Mary, CNA Applicant**

Application for certification denied based on violation of NRS 632.2852 (2d) requirements for certification.

Agreement for Fine in the amount of \$220.00 for violation of NAC 632.890 (36) practicing nursing without a license.

Found guilty of one count of NRS 632.320 (7) unprofessional conduct and NAC 632.890 (22) patient abandonment. Respondent's certificate was revoked. Respondent may not apply for reinstatement for two years.

Voluntary Surrender of Certificate in Lieu of Other Disciplinary Action for violation of NAC 632.890 (9) impaired practice.

Agreement for Fine in the amount of \$100.00 for violation of NAC 632.890 (36) practicing nursing without a license.
