- 1. Review, discussion, and action regarding administrator requirements of Apollo College, Las Vegas: M.A. Lambert asked questions on administrator R. Thuet's resume stating her concern about lack of teaching experience. D. Scott noted that some of part-time teaching was done prior to Ms. Thuet's graduating with her MSN and without a waiver, noting school would be responsible. It was moved and seconded that Ms. Thuet's credentials do not meet the requirements for an administrator of a nursing program pursuant to NAC 632.660. MOTION CARRIED.

ACTION

2. Review, discussion, and action regarding the University of Oklahoma College of Nursing/Orbis application for a nursing program in Nevada: This item was presented by R. Colosimo, PhD, the Board's education consultant. When asked for information on the current student nurse placements at Saint Rose, R. Lim did not have the current information. Sr. Mollie, Vice President for Mission Integration, Saint Rose Medical Center, read a letter of support from the hospital into the record. Administrator Dean Kenner, University of Oklahoma, responded to questions regarding the lack of budget information submitted to the Board. Representatives from Touro University and University of Southern Nevada expressed concern that the burden of establishing sufficient clinical placements as the program grows to 190 students was not addressed sufficiently in the application documentation. M.A. Lambert, NSBN Board member and liaison to the Education Advisory Committee summarized the concerns of the committee related to the application. R. Colosimo related the specific information needed to complete the application: a specific plan for clinical placements for the Oklahoma program when it reaches 190 students reassuring current schools that they will maintain at least their current placements, specific detail concerning the proposed faculty and clinical placements for specialty areas such as pediatrics, psychiatric and community placements, documentation of financial resources to sustain and support the program during the initial phases until self-sustaining financially, and an organizational chart showing relationships between Orbis education faculty and University of Oklahoma faculty. It was moved and seconded that the University of Oklahoma program was not advanced to provisional status. MOTION CARRIED.

3. Review and discussion regarding the second quarter NCLEX scores for Nevada nursing schools: R. Colosimo presented the NCLEX scores (Pearson Vue's official G-4 report) for the second quarter. M.A. Lambert commended Nevada State College for the marked improvement in scores. Board members expressed concern that other provisional schools were below 80% at this time.
4. Review and discussion regarding administrative change and update on implementation of consultant report at Nevada State College Nursing Program: Interim Dean Shirlee Snyder and Provost Di Mare presented the implementation and progress of plans to improve NCLEX scores. M.A. Lambert and D. Begley expressed support for the research being done to understand student success.
