## **Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of September 30, 2014, through November 26, 2014**

**Aincham, Luciana, CNA016408:** Renewal application denied for violation of NRS 632.320 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Arellano, Josilyn, CNA022842:** Renewal application denied for violation of NRS 632.320 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.
