**APRN000999:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, and NAC 632.890(27) failing to perform nursing functions in manner consistent with customary standards.

**Baker, Brian, CNA0326827:** Order for Reprimand, Fine and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, and NAC 632.890(27) when Respondent failed to perform nursing functions in a manner consistent with established or customary standards.
