Situation:

We have received several requests for information about what is needed for a Registered Nurse or Licensed Practical Nurse to be employed as a Nursing Assistant, either temporarily or permanently. Based on staff discussion and feedback from Donald H. Haight, I am proposing the following policies for your review. For the sake of clarity, I have separated the RN wishing to work as an LPN or NA from the LPN wishing to work as an NA.

Proposed Policies

Registered Nurse (Working as a Licensed Practical Nurse or Nursing Assistant)

A Registered Nurse may perform the functions of a Licensed Practical Nurse and/or a Nursing Assistant, however, he may not represent himself as a Licensed Practical Nurse or a Nursing Assistant unless he is credentialed as such. A Registered Nurse credentialed as a Licensed Practical Nurse or a Nursing Assistant must 1) practice within only one role during a particular assignment or shift and 2) consistently represent himself to the public as ONE of the following: R.N., L.P.N., or N.A. during a particular shift or assignment.

Procedure:

- 1. A Registered Nurse who wishes to hold herself out as a Licensed Practical Nurse must apply to the Board and pass the NCLEX-PN.
- 2. A Registered Nurse who wishes to hold herself out as a Nursing Assistant must apply to the Board and pass the NACEP (Nursing Assistant Competency Evaluation Program). Nursing Fundamentals will be accepted as a Nursing Assistant Training Program, which qualifies applicants for the NACEP.

The NCLEX-RN exam can not be substituted for the NCLEX-PN or NACEP exams.

Licensed Practical Nurse (Working as a Nursing Assistant)

A Licensed Practical Nurse may perform the functions of a Nursing Assistant, however, he may not represent himself as a Nursing Assistant unless he is credentialed as such. A Licensed Practical Nurse credentialed as a Nursing Assistant must 1) practice within only one role during a particular assignment or shift and 2) consistently represents himself to the public as ONE of the following: L.P.N., or N.A. during a particular shift or assignment.

Procedure:

1. A Licensed Practical Nurse who wishes to hold herself out as a Nursing Assistant must apply to the Board and pass the NACEP (Nursing Assistant Competency Evaluation Program). Nursing Fundamentals will be accepted as a Nursing Assistant Training Program, which qualifies applicants for the NACEP.

The NCLEX-PN exam can not be substituted for the NACEP exams.

MEMORANDUM

TO: Nevada State Board of Nursing

FROM: Whursing Practice Committee

RE: Recommendations

The Practice Committee recommends the following to the Board.

- 1) RNs and LPNs wishing to practice as a Nursing Assistant should sign a statement that they will not perform the activities of an RN or an LPN while working as a CNA. If persons practice beyond their authorized scope, they may be subject to discipline.
- 2) The Board accept passage of NCLEX-RN and/or NCLEX-PN in lieu of passing the Nurse Aid Exam and that the RN or LPN be able to submit an acceptable application and pay the fee and be certified as a nursing assistant.
- 3) Supported unanimously that RN and LPN scope of practice subsume CNAs.

Aloes this apply equally to RN's/LPN's whose license has been surrendered, revoked, suspended, or otherwise restricted?
