**Allen, Donna, RN816064:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (12) failing to respect or maintain a patient's right to privacy, and (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Baker, Evelyn, RN18892:** Renewal application for licensure denied for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.140 qualification for license.

**Baumann, Josephine, RN62816:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Miguel, Christine, RN95167:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890, (2) performing acts beyond the scope of practice of nursing, and (16) failing to properly document a controlled substance.

**Minton, Craig, RN90517:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (13) confidentiality conduct, (18) diversion of equipment or drugs, and (21) obtain, possess, furnish prescription drugs without authorization.

**Nash, Allen, RN39414:** Agreement for Voluntary Surrender of License in Lieu of other Disciplinary Action for violation of NRS 632.347 (1)(b)(1) Licensee is guilty of any offense involving moral turpitude.

**Nouri, Sana, RN69105:** Agreement for Suspension and Probation for violation of NRS 632.347 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, (1)(o) failing to comply with a Board order, NAC 632.890 (36) failing to comply.

**Spahn, Stacey, RN75345:** Agreement for Fine for violation of NRS 632.347 (1)(g) NAC 632.415 unprofessional conduct, NAC 632.890 and (26) violation of state/federal nursing law/regulation.

**Teshale, Eden, CNA030083:** Renewal application for certification denied for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Vanwayne, Julie, RN applicant:** Application for licensure denied for violation of NRS 632.347 (1)(m) action in another state.

**Vasquez, Piedad, CNA019503:** Agreement for Fine and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Wanjohi, Benson, RN88307:** Agreement for Reprimand and Continuing Education that includes courses in ethics, professionalism, and critical thinking for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 and (27) customary standards of practice.

**Ward, Michel, CNA013701:** Order of Revocation for violation of NRS 632.320 (1)(g) unprofessional conduct, NAC 632.890 (18) diversion of equipment or drugs, and (27) customary standards of practice.
