Call to Order: The meeting was called to order at 8:30 am, on Thursday, March 19, 2020.

Public Comment:

• Vicki Walker of Chamberlain University School of Nursing made a statement regarding agenda item A.6. The Commission on Collegiate Nursing Education (CCNE) made a statement on March 12, 2020 allowing flexibility in clinical hours and types of experiences for nursing students. V. Walker believes that decisions regarding students in the clinical setting are best left to the program and affiliating agency officials, in accordance with the local, state, and federal recommendations. V. Walker asked the Nevada State Board of Nursing (NSBN) to provide the schools of nursing with specific direction. Chamberlain University has suspended in-person classes and offers course work remotely. V. Walker asked the NSBN to adopt the same stance as CCNE allowing flexibility in the midst of a national emergency.

• Carla Wright, Program Director of the nursing assistant program at the College of Southern Nevada (CSN) made a statement regarding agenda item A.6. C. Wright expressed her support to allow authorization to the Executive Director to adjust clinical placements in response to the Nevada State of Emergency. CSN is in the process of setting up a plan for the Certified Nursing Assistant (CNA) students affected by the COVID-19 pandemic. The plan includes revisions to the number of hours of instruction, including hours spent in the clinical placements. Clinical sites have temporarily stopped permitting clinical rotations for student. The effects of delaying changes would have a negative impact on health, safety, and welfare of Nevadans because the CNA workforce will be compromised.

With both Reno and Vegas offices being closed to the public, fingerprint appointments and advisory committee meetings have been cancelled through the month of April. All CNA programs have been notified of communication with Headmaster about testing for CNA students. Pearson Vue has announced suspension of all testing for RN and LPN applicants through the middle of April. The Nevada State Board of Nursing will continuously assess the COVID-19 crisis and adapt accordingly. As events progress, board members and the public will be updated on the Nevada State Board of Nursing website. Thank you to Rhoda Hernandez for her continuous work in updates and IT support. Board Member President Mary-Ann Brown thanked C. Dinauer and all staff for their efforts.
