**Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of March 5, 2020 through June 5, 2020**

**Avila, Mario, CNA030476:** Renewal application for CNA certification denied for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Derouen, Angelique, CNA030948:** Renewal application for CNA certification denied for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Dever, Jennifer, CNA815885:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (27) customary standards of practice, and (28) causing harm to patient or family of patient.

**Dmyterko, Randy, RN84292:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (16) failing to properly document controlled substances and (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Gentry, Edith, RN applicant:** Application denied for violation of NRS 632.347 (1)(m) action in another state.

**Howard, Ixchel, RN77380:** Agreement for Reprimand, Monitoring, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (9) practicing nursing while, with or without good cause, her physical condition impairs her ability to act in a manner consistent with established or customary standards, or both, and (10) practicing nursing, if any amount of controlled

substance is present in the body of a nurse while on duty.

**Hudson, Joyce, RN85497:** Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Kreyling, Carrie, RN38610:** Agreement for Probation for violation of NRS 632.347 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, (1)(o) failing to comply with a Board order, and NAC 632.890 (36) failing to comply.

**Lotta, Jami, RN72727:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (12) failing to respect and maintain a patient's right to privacy, and (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Pacheco Ramirez, Esmeralda, CNA034024:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (12) failing to respect and maintain a patient's right to privacy, (13) violating a patient's confidentiality, and (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Rosario, Dorothy, RN461953:** Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Sabatini, William, RN applicant, CRNA applicant:** Order for Probation for violation of NRS 632.347 (1)(m) action in another state.

**Sanchez, Leslie, CNA 813501:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (20) inaccurate recording, falsifying, and (27) failing to perform nursing functions in a manner consistent with established or customary standards.

**Sanders, Dorothy, CNA019662:** Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (37) practicing without an active certificate.

**Sutherland, Sharon, RN09044:** Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (10) practicing nursing, if any amount of alcohol is present in the body of the nurse as determined by a test of breath while the nurse was on duty.

**Vertrees, Rianna, RN69653:** Agreement for Probation for violation of NRS 632.347 (1)(e) controlled substances and/or alcohol, and (1)(m) action in another state.
