Call to Order: The meeting was called to order at 9:00 am, on Wednesday September 23, 2020.

Public Comment:

- Tracy Whittier provided written public comment expressing concern for Board Member B. Murphy's comments and behavior. She requested information on how the public may submit complaints against Board Members.
- C. Dinauer made public comment acknowledging her DNP student, Elizabeth Field from the University of Reno. She also acknowledged Gail Trujillo for receiving her national certification through the Society for Human Resource Management Certified

- Professional. She thanked board members M. Brown and D. McKenzie for all their tremendous work for the Board and their endless amount of dedication.
- O. McGuiness thanked M. Brown and D. McKenzie for their work and mentoring. All their efforts are appreciated and congratulations to G. Trujillo on her certification.
- S. VanBeuge expressed her sentiments to M. Brown and D. McKenzie.
- J. Watts thanked M. Brown and D. McKenzie for their service to the Nevada State Board of Nursing and thanked D. McKenzie for her mentorship.

A. Board Governance and Administration

- 1. Review and discussion regarding Committee and Training Report by staff: C. Dinauer attended virtually the NCSBN annual conference. C Dinauer and M. Johnson both attended virtually the NCSBN NCLEX conference.
- 2. Review and discussion regarding Committee and Training Report by Board members: S. VanBeuge reviewed the outcomes and discussions had from the NCSBN annual conference. She explained that while Board was against the APRN compact, the NCSBN Delegate Assembly voted to approve the APRN compact. B. Murphy went over his highlights of attending the NCSBN NCLEX conference.
- 3. Approval of the July 22-33, 2020 Board meeting minutes: Approved under the consent agenda.
- 4. Executive Directors Report: C. Dinauer reported the possibility of upcoming vaccines for COVID-19 and working closely with program directors to get volunteers together to administer vaccines. In the month of June 2020, there was a ninety-nine (99) percent compliance with all CEU audits. Under the Boards direction to add staff to manage CNA Programs, there has been a new position created. M. Johnson explained the process for creating the job description for the new CNA Manager. The position has been offered and accepted with a start date of November 2nd. This person will work in partnership with M. Johnson in looking at pass rates and how to increase them with program enhancement.
- 5. Review, discussion, and possible action regarding Executive Director performance evaluation: Board members completed the Executive Director annual evaluation.
- 6. Review, discussion, and possible action regarding Fiscal Year 20/21 Goals and Objectives: The Board reviewed changes made to the objectives listed on the guide. It was moved and seconded to accept the changes made regarding Fiscal Year 20/21 Goals and Objectives. MOTION CARRIED.
- 7. Review, discussion, and possible action regarding composition of members serving on the Education Advisory Committee: S. McCord reviewed the statute that requires certain sizing of advisory committees. F. Olmstead reminded Board Members the Disability Advisory Committee and CNA Advisory Committee both have statutory requirements and the rest are policy. The Board discussed needing to know the requirements and criteria of committees in order to appoint members with confidence. R. O'Driscoll suggested board staff provide recommendation and perspective when bringing forth applications. It was moved and seconded to request board staff put together recommendations regarding composition of members serving on Education Advisory Committee and bring back to future board meetings taking into consideration Board discussion. MOTION CARRIED.
- 8. Review and discussion regarding legislative updates: M. Hillerby presented legislative updates. The first special session was dedicated to the budget and he foresees a tax

proposal in the next session because of economic impact of COVID-19. He explained the changes in voting due to the pandemic. In a previous board meeting, it was approved by the Board to require one (1) APRN as a member of the Board and will be presented in the next legislative session. It will also be presented that NRS 632.030 be updated to reflect two (2) RNs instead of three (3) and NRS 632.030(d) required to be a registered nurse. M. Hillerby also presented an update about the nursing compact and how COVID-19 has brought more attention to it. Governor Directive was issued allowing licensed healthcare workers to practice in the State of Nevada without applying during the State of Emergency and have been working with Senator Spearman to bring the compact forward.

- 9. Review and discussion regarding NSBN FY 19/20 HR Report Follow-up: G. Trujillo presented her HR Report to the Board. There is a long-term plan to review and update all job descriptions. She has been working with C. Dinauer in creating a list to start implementing in the HR role. The turnover rate was addressed and exit surveys are being utilized to identify common trends and areas for improvement. A CNA Program Manager position has been created and filled under the direction from the Board.
- 10. Review and discussion regarding statistics and trends related to scope of practice inquiries: S. McCord presented an update on two (2) quarters, one being before the pandemic and the other being during. The Board reviewed information regarding statistics and trends related to scope of practice inquiries.
- 11. Review, discussion, and possible action regarding possible revisions to the Fingerprint on Renewal Policy: Board staff explained the policy and procedure in regard to fingerprinting for renewal applications. M. Brown requested fingerprinting information be put into the next Nursing News magazine. The changes made are to include eight (8) screening questions instead of five (5), updated wording of the criminal conviction question, and the procedure for board staff processing renewal applications. It was moved and seconded to accept the revisions to the Fingerprint on Renewal Policy. MOTION CARRIED.

It was moved and seconded to approve the revisions to the Nevada State Board of Nursing Practice Decision titled The Role of the RN in Intubation. MOTION CARRIED.
- 3. Review, discussion, and possible action regarding approval of revisions to the Nevada State Board of Nursing Practice Decision titled APRN Scope in Intubation: S. Miller explained the history of the practice decision as well as the collaboration between advisory committees to make any necessary updates. RN and APRN were separated into two different practice decisions due to different roles in intubation. It was moved and

- 4. Review and discussion regarding Headmaster CNA Certification Exam pass rates by program for 3rd Quarter 2020: M. Johnson presented the 3rd Quarter 2020 Headmaster pass rates. There was discussion about waivers and using 100% simulation instead of clinicals due to the pandemic that may be affecting the pass rates. It was requested by the Board to bring back this agenda item as an action item for future board meetings.
- 5. Review and discussion regarding the NCLEX year-to-date first-time pass rates for 3rd Quarter 2020: M. Johnson presented the 3rd Quarter 2020 NCLEX pass rates. B. Murphey acknowledged schools with 100% pass rates. M. Johnson explained the drop in pass rates may be due to students testing further out from their graduation date but will wait until 4th Quarter to see if COVID-19 is affecting pass rates overall.
- 6. Review, discussion, and possible action regarding approval of the University of Nevada, Las Vegas' request to increase BSN nursing student enrollment by 8 students for the fall 2020 cohort: M. Johnson presented this agenda item. Steven Palazzo was present virtually to answer any questions and notified the Board this is a one-time request and will have sufficient staff to handle the increase. It was moved and seconded to approve the University of Nevada, Las Vegas' request to increase BSN nursing student enrollment by 8 students for the fall 2020 cohort. MOTION CARRIED. S. VanBeuge recused from this agenda item.
- 7. Review, discussion, and possible action regarding approval of Dr. Stephanie Durfor as Practical Nursing Program Chair at Las Vegas College: M. Johnson presented this item. Dr. Stephanie Durfor was present telephonically and explained her mission and vision to grow the LPN program to put more qualified LPN's in the community. It was moved and seconded to approve Dr. Stephanie Durfor as Practical Nursing Program Chair at Las Vegas College. MOTION CARRIED. B. Murphy recused from this agenda item.
- 8. Review, discussion, and possible action regarding Roseman University's request to establish an Academic Practice Partnership with Renown Health System: M. Johnson presented this item. Dr. Brian Oxhorn was present virtually and explained the plan for the partnership. He also explained the intent to build a healthcare workforce internally for Renown employees for RN to BSN, pre-licensure BSN, and MSN programs with no changes to admission requirements. The groups of 8 will reside in Reno at Renown with full time Roseman faculty as a supervisor. It was moved and seconded to approve Roseman University's request to establish an Academic Practice Partnership with Renown Health System. MOTION CARRIED.
