CALL TO ORDER: The meeting was called to order by S. McCord at 9:08 a.m.

PUBLIC COMMENT: None

A. APPROVAL OF MINUTES:

1. January 28, 2021 Sub Committee meeting: this item was moved to the next available meeting due to no quorum for this date.

B. OLD BUSINESS

- 1. Review, discussion, and possible action regarding recommendations to the Board regarding revisions to the Nevada State Board of Nursing practice decision titled Interfacility Transfers: N. Sirotek informed the committee that she had a draft completed but had some questions regarding who covers liability for the transporting nurse. F. Olmstead explained that this would be an employer/employee issue and is not required to be in the practice decision. A sub-committee meeting will be scheduled for this item. This item will be moved to the next committee meeting.
- 2. Review, discussion, and possible action regarding recommendations to the Board regarding revisions to the Nevada State Board of Nursing practice decision titled Telemedicine: This item was moved to the next committee meeting.
- 3. Review, discussion, and possible action regarding recommendations to the Board regarding revisions to EMS-RN licensure requirements: C. Dinauer presented this item. She gave an overview of why this item was being discussed and she thanked all of the members that joined the sub-committee meetings that were held. It was noted that all of the references used reflect the current standards in EMS practice. It was moved and seconded to have this draft item presented at the July 2021 board meeting.

C. NEW BUSINESS

- 1. Board meeting follow up: May 2021 Meeting: S. McCord present this item and informed the committee that 4 practice decisions were presented and approved by the board. C. Dinauer informed the committee that our offices are open and fully operational.
- 2. Legislative Update: F. Olmstead presented this item. He noted that the session ended on May 31, 2021. There were over 1,035 bills presented at this session. He gave an overview of ones that are related to healthcare. It was noted that the Governor did sign the bill to now require one our board members be an APRN; this does not change the number of people on the board. He informed the committee that nurses will now be required to complete a 2-hour cultural competency course each renewal and that there will be work force questions on the renewal applications. There were no laws passed regarding vaccine mandates.
