Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, September 22, 2021.

Public Comment:

- C. Dinauer introduced Doctor of Nursing Program (DNP) student Erin Pate who will be listening to the Board meeting. Ms. Dinauer congratulated Board President Dr. VanBeuge, for entering as an American Academy Nursing Fellow and being elected to the National Council of State Boards of Nursing (NCSBN) as District 1 Director representing the western states, Guam, Samoa, the Northern Mariana Islands and Alaska .

- C. Maes introduced the University of Nevada, Reno (UNR) DNP student Jerifaye Flores whom she is mentoring this semester.
- S. VanBeuge introduced student Brenda Delgado whom she is mentoring in the UNR DNP program. Students and their instructor from the University of Nevada, Las Vegas Campus (UNLV) School of Nursing are attending virtually. She thanked them for being a part of the regulatory process.
- O. McGuinness recognized healthcare workers throughout Nevada and thanked them for their service.

Pachak stated that prior survey deficiencies were rectified. Robert Peck, President of Perry Foundation, was present and made a statement. It was moved and seconded that the Board finds the Respondent in violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.890(9) practicing nursing while, with or without good cause, her physical, mental or emotional condition impairs her ability to act in a manner consistent with established or customary nursing standards, or both. Respondent is also in violation of NRS 632.347(1)(g) unprofessional conduct and NAC 632.890(10) practicing nursing, if any amount of alcohol or a controlled substance or dangerous drug that is not legally prescribed is present in the body of the nurse as determined by a test of the blood, saliva, breath, hair or urine of the nurse given while the nurse is on duty. It is Ordered that Respondent submit verification from a competent provider that Respondent is fit for duty as a nurse. It is further Ordered that Respondent's RN license be placed on probation for two (2) years. MOTION PASSED.
- b. Madison, Nancy, RN 16483, request for reconsideration. F. Olmstead presented this agenda item. The Respondent was present and made a statement; Ms. Madison was represented by counsel Lyn Beggs, Esq. who made a statement for the record. It was moved and seconded that the Board denies this request for reconsideration. MOTION PASSED.
- c. Newman, Michelle, LPN17453, request for reinstatement. K. Arguello presented this agenda item. The Respondent was present and made a statement. Evidence was admitted into the record and presented to the Board. President VanBeuge suggested the Board consider continuing this case when all evidence is available, including video evidence. It was moved and seconded to continue this matter to the next available Board meeting. MOTION PASSED.

MOTION PASSED. K. Arguello stated the Respondent provided his required CNA employment hours within the audit timeframe and requested the Board close this matter and grant licensure. It was moved and seconded to close this matter and grant the Respondent CNA licensure renewal. MOTION PASSED.
- g. Clayton, Dionne, CNA018418, request for reconsideration. F. Olmstead presented this agenda item. The Respondent was not present. It was moved and seconded to accept the request for reconsideration of CNA licensure. MOTION PASSED. F. Olmstead stated the Respondent provided the CE and employment hours required and requested the Board close this matter and grant CNA licensure renewal. It was moved and seconded to close this matter and approve the renewal application for CNA licensure. MOTION PASSED.
