Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, November 17, 2021.

LPNs, APRNs, CRNAs) to complete two hours of continuing education relating to cultural competency, diversity, equity, and inclusion. A special session of the Legislature is in the process of allocating redistricting.
