PUBLIC COMMENT:

1. C. Dinauer wished the committee and all APRN's a happy APRN week, which has been proclaimed by the governor.

A. A. Bellow Motioned to accept the May minutes with the amendment to item D. Section A. J. Packham seconded. Motion Carried. Minutes approved with the amendment.

B. OLD BUSINESS:

1. Review, discussion, and possible action regarding to the Board regarding The Role of the RN in Vaginal Speculum Examination practice decision. P. Strobehn motioned to

approve the practice decision with the addition of a CINAHL reference. A. Bellow seconds. Motion carried.

C. NEW BUSINESS

1. S. Miller congratulated Rhone D'Errico of his reappointment to the committee and welcomed Greg Jones as the new member to the committee.
2. C. Dinauer discussed the hybrid approach to the Board meeting. Participants are able to attend the meeting both in person and virtually which will likely be the new way Board meetings will be conducted. The Governor has appointed a new Board member Elizabeth Trilops. Her first Board meeting will be in November.
3. S. McCord discussed the quarterly Scope of Practice Questions that was fielded by Board staff. No questions or additional information was requested by the committee.
4. F. Olmsted gave the legislative update among the many changes F. Olmstead discussed the new two-hour Cultural Competency requirement that will begin January 1, 2022. Senate Bill 109 passed and will have new questions on the renewal application regarding race, ethnicity and or sexual orientation. Senate Bill 379 will have another set of questions on the renewal application regarding where you live, how many jobs do you have, how old are you etc. A new course has been implemented that will satisfy the opioid Continuing Education (CE) requirement; the Screening Brief Intervention and Referral to Treatment (SBIRT) approach. AB 442 passed, it is now a requirement to have an APRN Board member on the Board. A physical location is no longer a requirement for public meeting law. The Board's News Magazine will have a letter to reiterate all the legislative changes.
5. Review, discussion, and possible action regarding recommendations to the Board regarding the draft practice decision titled The LPN Scope of Practice Regarding Phlebotomy and Blood Sampling Collection. D. Etli motioned to approve the practice decision. R. D'Errico Seconds. Motion carried.
6. Review, discussion and possible action regarding recommendations to the Board regarding the draft practice decision titled LPN Scope of Practice Regarding Assessment and Minimum Data Set (MDS)/ Resident Assessment Instrument (RAI). D. Etli motioned to approve the practice decision. P. Burgio Seconds. Motion carried
7. Review, discussion, and possible action regarding proposed 2022 meeting dates. J. Packham Motioned to approve the 2022 dates. K. Fluitt Seconds. Motion Carried.
8. Review and discussion of need for edits or updates to NAC 632.890 as they pertain to advanced practice nursing. The committee are in an agreement to bring the item back to discuss at the next meeting.
