CALL TO ORDER: The meeting was called to order by M. Johnson at 9:02 a.m.

PUBLIC COMMENT: C. Dinauer thanked the educators for responding to the email regarding the nursing shortage.

A. APPROVAL OF MINUTES: October 8, 2021, minutes were reviewed and approved as written. MOTION CARRIED.

C. NEW BUSINESS:

# Nevada State Board of URSING

- 1. Review and discuss the requirement for RN/LPN faculty expertise to teach in a specific area. The committee members collaborated and provided ideas on training and matching nurses in their specialty areas, requiring updated annual resumes, assisting faculty in mentoring new faculty, using a course coordinator as a mentor, co-teaching courses, and providing access to the educator's teaching essentials.
- 2. Review and discuss the "pros and cons" of the utilization of the preceptor model. M. Johnson shared a preceptor handout with the committee members; she discussed that national NCLEX pass rates are down to 82%. The committee members collaborated and discussed the pros and cons of preceptorships. The pros include:cost-saving measures such as every student could be worth .01 credit, the preceptor is the direct supervision over the student and not the faculty, Nevada State Board of Nursing (NSBN) accepts 120 hours of preceptorship for 10 hours continued education hours, 1:8 model does not apply to preceptorship, and comfort levels for new nurses that transition into the workplace. The cons are: nurses experience burnout, struggles with clinical placements, limited resources, lots of preparation, qualifications for nurses, and last-minute cancellations with the clinical placement in the consortium. A. Donnelli stated she does not support the preceptorship model and feels it's too challenging for the agencies. The committee recommended that the Nevada Hospital Association (NHA) meet every 6 months to discuss the issues. V Walker discussed the Nevada Alliance of Nursing Excellence (NANE) reorganization to rebuild under Nevada Action Coalition (NAC) and will follow up.
- 3. Review and discuss progress of the EAC simulation sub-committee. M. Johnson advised the committee the simulation sub-committee is looking at a long-term sub-committee. The committee will address 1-2 objectives and goals at each meeting. The simulation sub-committee meeting is open to everyone and encourages attendees to join. Dr. Heather Peralta joined the simulation sub-committee as the speaker. Dr. Peralta has an approved accredited simulation program and provided insight on how a simulation program worked for her in central Florida.
- 4. Review and discuss different teaching models. M. Johnson shared handouts and a PowerPoint that discussed different teaching models such as; Peer-assisted Learning, one to one Mentorship model, Web/computer-assisted learning and distance learning, Simulation-assisted Learning, Concept Map and example, Flipped classroom model, Creative Drama, Cooperative learning, Teamwork/based Learning, Problem-based Learning, Portfolio, and Competency-based Education.

  - 1. Review and discuss 4<sup>th</sup> quarter NCLEX pass rates.
  - 2. Review and discuss follow-up with the Nevada Alliance of Nursing Excellence (NANE).
