

### **BOARD MEETING MINUTES**

January 19 - 20, 2022

Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, January 19,

### **Public Comment:**

 Annette Rousseau, RN, licensed in Nevada. Ms. Rousseau stated that she is an avid researcher on bioterrorism, weapons, Covid-19, and vaccines. Ms. Rousseau read an excerpt from Dr. Robert Malone's (inventor of the mRNA vaccine technology) narrative.

### A. Board Governance and Administration

Johnson explained that CSN would attend the March board meeting giving board staff time to conduct a site visit and allowing CSN the opportunity to develop a plan. CSN has hired a new Director who will be placed on the March agenda for approval. It was moved and seconded to accept the Board meeting minutes of November 17-18, 2021. MOTION PASSED.
- 2. Review, discussion, and possible action regarding FY 21/22 Goals and Objectives. Approved under the Consent Agenda.
- 3. Review, discussion, and possible action regarding Staff / Board conference/training reports. Approved under the Consent Agenda
- 4. Review, discussion, and possible action regarding updates to the policy, 'Continuing Education / Employment Audit Violations.' Approved under the Consent Agenda.

- 7. Executive Director Report. C. Dinauer reported on the status of Cultural Competency courses for nurses. All RNs that are required to renew in January and February 2022 were notified by mail of the requirement. At the beginning of January, there were only two courses that met the statute's requirements. Since then, more Cultural Competency courses have been reviewed and posted to our website. Ms. Dinauer has been working with the Governor's office and Public Health to collaborate on the nursing shortage. The apprentice nurse program is a big push to hire student nurses at facilities. The NSBN Annual Report is published and mailed out to the Board and posted on the website.
