Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of April 7, 2022 through June 27, 2022

Anthony, Meon, CNA033689: Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Borbon, Oscar, RN40496: Agreement for Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.347(1)(b) guilty of any offense, and (1)(n) has engaged in conduct likely to endanger the general public.

Bugarin, Catherine, RN 823403: Agreement for Reprimand and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.890(24) failing to collaborate with the health care team, (25) failing to observe/report, and (27) customary standards of practice.

Connelly, Maria Cristina, CNA032908: Renewal application denied for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Elms, Jacquelyn, RN84757: Agreement for Reprimand, Continuing Education, and Monitoring for violation of NRS 632.347(1)(g) unprofessional conduct, and NAC 632.890(9) practicing nursing while, with or without good cause, her physical condition is impaired.

Fisher, Jessie, RN88508: Agreement for Reprimand and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct and NAC 632.890(24) failure to collaborate with other members of the health care team as necessary to meet the health needs of a patient.

Fountain, Anjela, RN82438: Order for Reprimand and Fine for violation of 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Hall-Brown, Celeste, LPN17560: Order for Probation for violation of NRS 632.347(1)(g) unprofessional conduct; (1)(o) failing to comply with Board order, NAC 632.890(18) diversion of equipment or drugs, (21) obtain, possess, furnish prescription drugs without authorization, (27) customary standards of practice.

Halloway, Cassandra, CNA033635: Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Kreyling, Carrie, RN38610: Agreement for Probation for violation of NRS 632.347(1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, (1)(o) failing to comply with a Board order, and NAC 632.890(36) failing to comply.

Lauer, Sarah, RN68914: Agreement for Fine for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Mc Lauchlin, Todd, RN25596: Agreement for Reprimand and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.890(20) inaccurate recording, falsifying, and (27) customary standards of practice.

Redwine, Charles, RN75264: Order for Reprimand and Fine for violation of 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Sabatini, William, RN 831336, CRNA 831336: Order for Revocation for violation of NRS 632.347(1)(o) failure to comply, (1)(m) discipline in another state, (1)(g) unprofessional conduct, NAC 632.890(9) practice of nursing while, with or without good cause, his physical, mental, or emotional condition impaired his ability to act in a manner consistent with established or customary nursing standards, or both; and (37) engaging in the practice of nursing without a license.

Seniga, Zuri, CNA031054: Agreement for Fine and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Stanton, Debra, RN87529: Agreement for Fine for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Tolentino, John, RN68993, APRN 835286: Agreement for Suspension and Probation for violation of NRS 632.347(1)(e) uses any controlled substances, dangerous drugs, or intoxicating liquor, (1)(g) unprofessional conduct, (1)(k) falsified information to obtain controlled substances, (1)(o) failing to comply with a board order, and NAC 632.890(36) failing to comply.

Walker, Gwendolyn, CNA012457: Agreement for Reprimand and Fine for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

West, Priscilla, RN86285: Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.

Yuhmo, Wanesa, RN71154: Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347(1)(g) unprofessional conduct, NAC 632.415 unprofessional conduct, and NAC 632.890(26) violation of state/federal nursing law/regulation.
