CALL TO ORDER

1. Review and discussion of need for edits or updates to NRS 632.237 and NAC 632.890 as they pertain to advanced practice. P. Strobehn presented her draft to the subcommittee, the subcommittee discussed and suggested two areas to be revised. Under 632, unprofessional conduct number 1 on the draft, it was decided to remove conviction of criminal offenses from the first section as it is addressed during the application/ renewal process. In the same section number 5, failing to maintain accurate health care records, it was decided to incorporate it into NAC 632.256. F. Olmstead will make the changes and add the appropriate language and bring back for the subcommittee to review before it is presented to the APRN Advisory Committee.
