**PUBLIC COMMENT:** S. McCord informed the committee that there are two members completing their second terms on the committee in July. He also welcomed the two newly appointed members, N. Kinder and P. Adzima. Both new members gave their nursing history to the committee.

  - d. Gastrostomy Tube: it was moved and seconded to approve this practice decision with up-to-date references.
  - e. Hemovac and/or a Jackson-Pratt Surgical Drain: G. Evors will add references and fix grammatical errors. This item will be presented at the next committee meeting.

#### C. NEW BUSINESS

1. Board meeting follow-up: May 2022 Board Meeting: K. Arguello updated the committee on the two regulation adoption hearings; they are the Apprentice Nurse practice locations being updated and the definition of delegation that will now include LPNs in the regulation. These regulations are now set for a hearing with the legislative commission. S. McCord informed the committee that the school nurse practice decision has been approved and is updated on the Board's website. He also informed the committee that G. Evors and N. Sirotek were re-appointed to the committee and that this committee now has 11 members.
2. Review and discussion regarding quarterly Scope of Practice Calls: S. McCord presented this item. N. Sirotek inquired about an FAQ section for the scope of practice calls; S. McCord will review it. No other discussion.
