

**Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of July 22, 2022 through October 13, 2022**

**Aguilar, Norma, CNA031935:** Renewal Application denied for violation of NRS 632.347 (1)(g) unprofessional conduct, NRS 632.415 unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.

**Aradanas, Emarvic, CNA028878:** Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (22) leaving an assignment without properly notifying the appropriate personnel or abandoning a patient in need of care and (42) engaging in any other unprofessional conduct with a patient that the Board determines is outside the professional boundaries generally considered acceptable in the profession.
