1. C. Dinauer gave an update from her executive report presented at the March, May, and July Board meetings. C. Dinauer discussed the governor's state of emergency declaration as it ended on May 20, 2022; Board staff notified nurses working on the waiver that the declaration was ending and they needed to obtain licensure. Two regulation workshops took place in May pertaining to the Nurse Apprentice and Delegation and Supervision. Both regulation changes are now posted on our website. C. Dinauer discussed her presentation at the Interim Commerce and Labor, where she spoke about the Nurse Compact and moving forward with the compact this legislative session. The July Board meeting was the business meeting, where the Board gets their annual training and review and approve the annual budget and policies. The Bioterrorism continuing education course was discussed and was questioned if it should remain a required course. To discontinue the Bioterrorism would require a change in statute.
2. S. McCord presented the Scope of Practice Questions to the committee with no questions.
3. Review, discussion and possible action related to potential addition of APRN Education to Regulations and Statutes. B. Day, G. Jones, and J. Packham expressed immense support for the additions to the APRN education regulation and statutes.
