CALL TO ORDER: The meeting was called to order by Elaine Ralph at 9:01 a.m.

# C. NEW BUSINESS:

1. S. McCord gave Board follow up from the May Board meeting and announced two regulatory changes that have been proposed and are under the LCB files, RO19-22 RO18-22. The two proposed revisions are related to delegation and apprentice nursing both were approved by the Board. The School Nursing practice decision was approved and can be found on the Boards website under Practice Decisions. S. McCord reported on the July Board meeting, the Executive Director report was specific to the ongoing efforts to get the Nurse Compact passed, the most recent survey of our licensees shows 90% in favor of the Nurse Compact. The Bioterrorism was discussed and reviewed as it is a one-time required course no further action took place with the course. The Board selected

- their 2023 meeting dates. The Board is approaching their 100<sup>th</sup> anniversary, a special edition of the Nursing News magazine will be put out. S. McCord suggested the committee put together an article for the edition as a lot of people will be reading the magazine. Coral Paris RN, LADC gave a presentation on Alcoholics Anonymous which the Board was pleased with.
- 2. S. McCord presented the Scope of Practice calls for the last two quarters. The overall calls have doubled in the amount. Over the whole fiscal year from July 2021 through June of 2022, Board staff have taken 150 more calls that we had in the previous fiscal year.
- 3. Review and discussion regarding awareness, recognition, and support for substance use in nursing professionals and SUD evaluation tools. Both B. Kiehn and P. Kapsar discussed their work regarding the assessment tools and documents that were presented to the committee. The committee will look over the documents that were presented and will compile recommendations and or checklists that they would like to see in the draft. Once the committee has completed their part the recommendations will then go to P. Kapsar to complete the rough draft. R. Scarpa will send resources to add to the draft.
