1. Review, discussion, and possible action related to examining the National Council of State Boards of Nursing (NCSBN) Model Acts related to Simulation and the Simulation Resource List to develop a simulation tool kit. The sub-committee discussed, collaborated, and collected information regarding the NCSBN Model Acts and Simulation Resource List to help create an evidence-based framework for a tool kit. A few examples were discussed, such as:

Nevada State Board of NURSING

1. Simulation faculty should be certified or planning to become certified within 5 years. Certification within 5 years is a recommendation, not a requirement. The sub-committee will put together resources to assist with becoming certified.
2. Simulation training models. Policy states to determine guidelines for approved RN and LPN programs for simulation may be substituted for traditional clinical experiences but should not exceed more than 50%.
3. Formal training for Simulation. The sub-committee discussed how formal training is not required but is recommended. The sub-committee will research further to define formal training with recommendations and bring it back to the next meeting.

D. Recommendations for agenda items for the next meeting to be held on July 29, 2022.

1. Review and discuss the Best Practices Articles.
2. Review and discuss definitions (glossary terms)
3. Review and discuss 1 or 2 objectives on each agenda.
