C. NEW BUSINESS:

1. F. Olmstead gave an update from the November 2022 Board meeting. F. Olmstead announced the Board will be celebrating the 100th Anniversary in March of 2023. A discussion took place regarding LPN's scope of practice to include the pronouncement of death; this would require two statutes to be changed. The Board has changed the format of the News Magazine to a Newsletter. The Newsletter will be distributed via email and will be posted on the Board's website. A new English Proficiency provider has been accepted and listed on the website. The Nurse Apprentice program was granted twenty million dollars to help nurse apprentices work in more diverse locations. The Board appointed new committee members to the Advisory Committees. The Nevada Nurse Compact will go forward this legislative session, the interim committee of commerce and labor has put forward a bill draft request in favor of the nurse compact.
2. Review and discussion regarding the Nevada State Board of Nursing Scope of Nursing Practice Decision Making Framework to include delegation of nursing tasks to assistive personnel. The committee discussed and decided to continue the discussion to the next meeting so that additional information could be gathered. The committee wants ED technicians to be included with the assistive personnel. J. Hesterlee will send in the regulations for personal care agencies. The Arizona and North Carolina delegation tree will be reviewed and distributed at the next committee meeting.
3. S. McCord presented the Scope of Practice Questions and trends.
