A. APPROVAL OF MINUTES: H. Church Motioned to approve the December 6, 2022, minutes with the correction to include DNP to G. Evors credentials. J. Hesterlee Seconded. Motion Carried. L. Kennedy Motioned to approve the Subcommittee 12/15/2022, Minutes as written. N. Kinder Seconded. Motion Carried.

B. OLD BUSINESS:

1. Review and discussion regarding the Nevada State Board of Nursing Scope of Nursing Practice Decision Making Framework to include delegation of nursing

tasks to assistive personnel. The committee discussed and reviewed the materials that were provided for review and decided a subcommittee would be the best option to proceed. L. Kennedy, J. Hesterlee, and G. Evors have volunteered to serve on the subcommittee to draft the assisted personal delegation tree.

2. Review, discussion, and possible action regarding the proposed practice decision request titled: Nitrous Oxide/Oxygen administration outside the operating room. L. Kennedy Motioned to approve the practice decision with the correction discussed. H. Church, Seconded. Motion Carried. The practice decision will go to the Advanced Practice Registered Nurse Advisory Committee for further review.

C. NEW BUSINESS:

1. C. Dinauer gave an update from the January 2023 Board meeting. C. Dinauer discussed the Board's assistance with fast-tracking licenses to help with the RSV influx. The Board has a bill for the Nurse Licensure Compact, AB-108, and is set to be heard by the Assembly Committee on Commerce and Labor. Governor Lombardo has issued Executive Orders that require Occupational Licensing Boards to review their regulations that may pose a barrier to licensing. The Board is reviewing all policies to comply with the Executive Order. The Board will celebrate the 100th Anniversary in April at the Governor's mansion in Carson City. The Board accepted the Jackson Pratt Surgical Drain practice decision with the proposed revisions. The Board approved and reviewed CNA training programs. Credentia is the new CNA testing vendor; the Board no longer uses Headmaster.
2. S. McCord noted the Scope of Practice data is still being collected and will be presented at the next committee meeting.
