

<u>Disciplinary and Licensure/Certification Actions taken by the Nevada State Board of Nursing for the period of March 11, 2023, through April 26, 2023</u>

Axel, Rachal, CNA036499: Voluntary Surrender of Certificate in Lieu of Other Disciplinary Action for violation of NRS 632.347 (1)(g), unprofessional conduct, NAC 632.890 (35) misappropriating patient property.

Cosio, Ixchel, RN77380: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct, (1)(o) failing to comply with a Board order, and NAC 632.890 (36) when Respondent failed to comply with a condition, limitation or restriction which has been placed on her license.

Echeverria, Tamara, LPN09553: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (9) practicing nursing while, with or without good cause, her physical, mental or emotional condition impairs her ability to act in a manner consistent with established or customary nursing standards, or both, (27) failing to perform nursing functions in a manner consistent with established or customary standards.

Fernandez, Jason Anthony, RN94812:

Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (2) performing acts beyond the scope of the practice of nursing, and (20) inaccurate recording, falsifying or otherwise altering or destroying records.

Govain, Alonzo, CNA 830459: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (24) failing to collaborate with other members of the health care team as necessary to meet the health needs of a patient.

Irwin, Anthony, CNA031189: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (36) when Respondent failed to comply with a condition, limitation or restriction which has been placed on his or her license or certificate.

Keeling, Charmaine, RN60728:

Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (2) practice beyond scope, (20) inaccurate recording, falsifying or otherwise altering records, and (27) customary standards of practice.

Knipp, Brandon, RN 831498: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) failing to perform nursing functions in a manner consistent with established or customary standards.

Lawrence, Zorelda, CNA033002:

Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (2) practice beyond scope and (27) customary standards of practice.

Mashrick, Thomas, RN 813457:

Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) failing to perform nursing functions in a manner consistent with established or customary standards.

McDonald, Susan, RN57156: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct and, NAC 632.890 (36) when Respondent failed to comply with a condition, limitation or restriction which has been placed on her license.

Morgan, Margaret, RN52146: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and, NAC 632.890 (18) diverting supplies, equipment, or drugs for personal or unauthorized use.

Oki, Laura, APRN002091: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (26) failing to abide by any state or federal statute or regulation relating to the practice of nursing, and (27) customary standards of practice.

Rubinstein, Michelle, RN 848501:

Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.347 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, and NAC 632.890 (10) positive drug screen on duty and (27) customary standards of practice.

Rucker, Brandon, LPN17887: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (24) failure to observe the conditions, signs and symptoms of a patient, to record the information or to report significant changes to the appropriate persons, and (32) when endanger the safety of the general public, patients, clients or coworkers by making actual or implied threats of violence or carrying out an act of violence.

Ruiz, Toni, RN76294: Agreement for Reprimand, Continuing Education, and Monitoring for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (10) positive drug screen while on duty.
