AB- 401 has progressed, this is the authority to allow the ratio of 12 students to one faculty member.

- 2. The committee discussed APRN's identifying themselves as a doctor, it was agreed amongst the committee that an APRN can call themselves a doctor but must clarify their credentials.
- 3. S. McCord presented the quarterly Scope of Practice Questions and trends.
