Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, November 15, 2023.

A. Board Governance and Administration

- 1. Approval of the September 20-21, 2023, Board meeting minutes. C. Dinauer pulled the minutes from the consent agenda for edits that included C9 to include recusals from Susan VanBeuge and Cheryl Maes and C10 to read; review, discussion, and possible action related to Nevada State University Bachelor of Science in Nursing program's request to increase admissions to a maximum 384 students per year and one recusal from Branden Murphy. It was moved and seconded to approve the September 20-21, 2023, minutes with the requested edits. MOTION PASSED.
- 2. Review, discussion, and possible action regarding FY 23/24 Goals and Objectives. Approved under the Consent Agenda.
- 3. Review, discussion, and possible action regarding NSBN Staff/Board conference/training report. Approved under the Consent Agenda.
- 4. Review and discussion regarding 1st quarter FY 23/24 NSBN financials. C. Dinauer presented the agenda item. K. Neuhauser went over the financials in detail and was available for questions. No further discussion.
- 5. Review, discussion, and possible action regarding approval of FY 22/23 Annual NSBN Audit. C. Dinauer presented the agenda item. K. Neuhauser and Suzanne Olsen-Auditor provided details regarding the FY 22/23 NSBN Audit and concluded there were no findings. It was moved and seconded to approve the FY 22/23 Annual NSBN Audit as written. MOTION PASSED.
- 6. Executive Director Report. C. Dinauer provided an update regarding the Las Vegas office. The Las Vegas office has found a location, but is in the process of negotiations, and will provide an update once completed. C. Dinauer welcomed the two new Board members, Tyler Johnson and Elizabeth De Leon-Gamboa.
- 7. Review, discussion, and possible action regarding the FY 22/23 Annual Report. C. Dinauer discussed the Annual Report and provided details that included statistics, education, and licensure. S. VanBeuge thanked the staff for completing the Annual Report. It was moved and seconded to accept the FY 22/23 Annual Report. MOTION PASSED.
- 8. Review and discussion regarding scope of practice questions received by board staff for the first quarter FY 2023/24. S. McCord presented the agenda item. S. McCord reported the recent trends with all levels of licensure and provided answers to the scope of practice questions listed in the written report. There were no additional questions.
- 9. Review, discussion, and possible action regarding the elimination of the process of capturing fingerprints by Board staff at NSBN offices. F. Olmstead presented the agenda item with information that included itemized costs, fees, and the quantity of fingerprints completed within the last year of 2023 at the NSBN offices versus number of fingerprints completed outside of the NSBN offices. It was moved and seconded to approve to eliminate the process of fingerprints at the NSBN offices. MOTION PASSED.
- 10. Review, discussion, and possible action regarding changing the May 15-17, 2024, board meeting date to May 22-23, 2024. C. Dinauer presented the agenda item. Discussion included, Board President, Richelle O'Driscoll would not be available if the date changed, but Vice President, Cheryl Maes would be available to step in as the interim Board President for the May 22-23, 2024, Board Meeting. It was moved and seconded to approve the date change to May 22-23, 2024. MOTION PASSED.

Dinauer presented the agenda item with the following updates, the Reno NSBN Office is moving to a new location on Plumas and McCarren, 1st office suite is for office staff and the 2nd office suite is for a board room, which includes 2 offices and kitchen. No exact moving date was provided due to the holidays, but potentially could be around the first week of January 2024.
