CALL TO ORDER: The meeting was called to order by Barbara Day at 3:00 p.m.

- A. APPROVAL OF MINUTES: G. Jones Motioned to approve the May 9, 2023 minutes as written. A. Cormican Seconded. Motion Carried.
- B. OLD BUSINESS: None
- C. NEW BUSINESS:

1. S. McCord gave an update from the July Board meeting and announced there are new Board officers. Richelle O’Driscoll was elected as Board President and is the first consumer president. The Vice President is now Cheryl Maes and the Board Secretary is Brandon Murphy. The annual budget was reviewed and approved which included a budget for moving expenses, both the Las Vegas and the Reno office will be moving to new locations. The Nitrous practice decision went before the Board and was approved and is now on the Boards website.
2. C. Dinauer gave an update on SB-336 related to CRNA scope of practice, CRNAs can prescribe under the supervision of a MD if they are in a critical access hospital.
3. Review, discussion, and possible action regarding the new Nevada State Board of Nursing Scope of Nursing Practice Decision Making Framework addressing the delegation of nursing tasks to assistive personnel. The Committee discussed the practice decision and decided it would be best for a subcommittee to form and further the progress on the practice decision. P. Burgio, J. Packham, A. Cormican and R. Scarpa will work together on the subcommittee with L. Kennedy and S. McCord. C. Dinauer will bring additional information from the National Council State Boards of Nursing Delegate Assembly regarding unlicensed personal.
4. D. Barisone Motioned to approve the 2024 committee meeting dates. A. Cormican Seconded. Motion Carried.
5. S. McCord presented the quarterly Scope of Practice Questions and trends.
6. F. Olmstead gave a legislative update and discussed AB-267 with a change to the Cultural Competency from two to four hours, this is effective January 1, 2024. There is a new 2-hour HIV Stigma CE that’s being required, additional information will be sent out. Anesthesiology Assistants can provide anesthesia under the supervision of the Anesthesiologist. SB-375 is two ten million grants to expand graduate and under graduate nursing programs for higher education programs. AB-401 changed the ratio for faculty in education, it is now twelve students to one.
