

BOARD MEETING MINUTES

January 17-18, 2024

Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, January 17, 2024.

Public Comment:

A. Board Governance and Administration

- 1. Approval of the November 15-16, 2023, Board meeting minutes: Approved under the Consent Agenda.
- 2. Review, discussion, and possible action regarding FY 23/24 Goals and Objectives: Approved under the Consent Agenda.

- 4. Executive Director Report. C. Dinauer provided updates regarding fingerprints no longer being completed in Reno and Las Vegas offices, with no issues to report. The Reno office officially has relocated to its new location. The Las Vegas office is still in the process of searching for a new location. C. Dinauer provided information regarding a shortage with the medication of "Erythromycin." For newborns alternative medications are being provided to nurses such as "ceftriaxone" if erythromycin is unavailable.
- 5. Review, discussion, and possible action regarding amendment to the March 22-23, 2023, approved meeting minutes. K. Arguello presented the agenda item. It was moved and seconded to accept the corrected minutes as written. MOTION PASSED.
- 6. Review and discussion regarding board committee reports. C. Dinauer presented the agenda item. R. O'Driscoll requested a continuance to a future board meeting. No further discussion.
- 7. Review, discussion, and possible action regarding future board meeting dates and locations in 2024 and 2025. C. Dinauer presented the agenda item. Discussion included cost of savings, less wear and tear on equipment, and access to a new board room at the Reno location. It was moved and seconded to accept the updated future board meeting dates and locations. MOTION PASSED.
- 8. Review, discussion, and possible action regarding moving the November 13-14, 2024, board meeting to November 20-21, 2024. C. Dinauer presented the agenda item. It was moved and seconded to accept the date change. MOTION PASSED.
- 9. Review and discussion regarding presentation to Board member Brandon Murphy. C. Dinauer presented the agenda item and acknowledged and thanked B. Murphy for his participation as a board member. R. O'Driscoll and S. VanBeuge thanked and acknowledged B. Murphy for his service, perspective, fresh voice, and individualism as a board member. B. Murphy was unable to attend the presentation.
- 10. Review, discussion, and possible action regarding notice of intent to act upon a regulation, LCB File no. R060-23. F. Olmstead presented the agenda item. F. Olmstead discussion included the laws, procedures, and LCB File No. R060-23. Mike Hillerby was present and available for questions. It was moved and seconded to adopt the notice of intent to act upon a regulation with the changes as written. MOTION PASSED.

B. Nursing Practice

1. Review, discussion, and possible action regarding application for appointment to the CNA Advisory Committee. M. Johnson and T. Pachak presented the agenda item. It was moved and seconded to approve the application of Gail McGuill, RN 828893, AARP Representative to the CNA Advisory Committee. MOTION PASSED.

- 2. Review, discussion, and possible action regarding application for appointment to the Licensed Practice Nurse Advisory Committee. S. McCord presented the agenda item and stated there will be no action to take, due to Monica Green being appointed to another committee. No further discussion.
- 3. Review, discussion, and possible action regarding application for appointment to the Nurse Practice Advisory Committee. S. McCord presented the agenda item with one available opening. It was moved and seconded to accept the appointment of Monica Green, RN42856 to the Nurse Practice Advisory Committee. MOTION PASSED.
- 4. Review, discussion, and possible action regarding applications for Board-approved Substance Use Disorder Evaluator. S. McCord presented the agenda item. It was moved and seconded to approve the application of Leslie Dickson, MD, FAPM, LFAPA as the Substance Use Disorder Evaluator. MOTION PASSED.

C. Education

- Review and discussion related to 2023 4th quarter and end of year NCLEX first time passrates. M. Johnson presented the agenda item, discussion included updates regarding the PN Programs, Nevada rankings, RN and PN pass rates, and was available for questions. There was no further discussion.
- 2. Review and discussion regarding the NCSBN Annual Report as it relates to Full time vs. Adjunct/Part time faculty. M. Johnson presented the agenda item. Discussion included the process, regulation, and ratios of full-time vs adjunct faculty and was available for questions. There was no further discussion.
- 3. Review, discussion, and possible action regarding Arizona College of Nursing first time pass-rates for 2022 and 2023. M. Johnson presented the agenda item. Dr. Dalas Jones, Dr. Barbara Hall, and Nick Mansor were present, provided a statement, and were available for questions. Discussion included adding two additional assistant deans, increased faculty office hours to offer additional tutoring, conducting weekly faculty meetings to discuss assignments, curriculum, etc. It was moved and seconded for Arizona College of Nursing to be placed on conditional approval, conduct a review of the program via site visit, identify and correct the deficiencies, and submit a report within six months after the board establishes a plan. The report must include proof of compliance to withdraw from the conditional approval or if the program does not comply with the plan, the board will remove the program from the list of programs approved by the board. MOTION PASSED.
- 4. Review, discussion and possible action regarding Roseman University Health Sciences College of Nursing November 8-9, 2023, Site Visit. Approved under the Consent Agenda.
- 5. Review, discussion and possible action regarding College of Southern Nevada 6-month follow-up RN Site Visit. M. Johnson presented the agenda item. Dr. Elizabeth Soliman-interim was present and provided a statement. Discussion included over all pass-rates, site visit conducted, prepared a correction action plan, pass rates have improved and resolved some deficiencies, student participation increased, faculty competition, clinical placements, using ATI, the proper use of simulation. It was moved and seconded to accept the site visit findings and request a follow-up within the next 6 months. MOTION PASSED.
- 6. Review, discussion, and possible action regarding College of Southern Nevada 6-month follow-up PN Site Visit. M. Johnson presented the agenda item. Dr. Elizabeth Soliman and

Evette Fuerniss were present and provided statements. Discussion included NCLEX pass rates for 2023, 3 out of 5 deficiencies have been corrected within 18 months, continued interactions with consultants, planned interventions, ACN deficiencies challenges, Fall ACN site visit scheduled, and simulation is used effectively. It was moved and seconded to accept the site visit report as written and requested a follow-up every 6 months until issues related to accreditation are resolved. MOTION PASSED.

- 7. Review, discussion, and possible action regarding appointment of Dr. Sherry Lindsey as the Nursing Site Director for Grand Canyon University accelerated Bachelor of Science in Nursing Henderson, NV. M. Johnson presented the agenda item. Dr. Sherry Lindsey was present and provided a statement. It was moved and seconded to approve the appointment of Dr. Sherry Lindsey as the Nursing Site Director. MOTION PASSED.
- 8. Review and discussion related to Chamberlain University College of Nursing's Earn to Learn Model. M. Johnson presented the agenda item. Dr. LaTricia Perry was present and provided a statement. Discussion included NCSBN pushing for practice partnerships, education, NAP's, patient care roles, enabling students, developing more pipeline for students in the workforce, 2 of 23 campuses have implemented the pilot program, 3-year curriculum, preceptorship model, and FAQ's. No further discussion.
- 9. Review and discussion regarding Credential CNA Certification Exam 2023 fourth quarter and annual pass rates. T. Pachak presented the agenda item. Discussion included 12 out of 14 programs are above 80% for fourth quarter, 17 out of 24 were above 80%. Additional updates with fourth quarter and annual pass rates were discussed with the annual pass rate of 91%. No further discussion.
- 10. Review, discussion, and possible action regarding Great Basin College Nursing Assistant Training Program's request for removal from remediation plan. T. Pachak presented the agenda item. Gina Johnson was present and provided a statement. It was moved and seconded to grant the request for removal of the remediation plan. MOTION PASSED.
- 11. Review, discussion, and possible action regarding Standards of Excellence Nursing Assistant Training Program's request for removal from remediation plan. T. Pachak presented the agenda item. Joan Dizon was present and provided a statement. Discussion included learning resources, personalized remediation plan for students, and current pass rates of 96%. It was moved and seconded to grant the request for removal of the remediation plan. MOTION PASSED.
- 12. Review, discussion, and possible action regarding Standards of Excellence Nursing Assistant Training Program's biennial site survey conducted on December 5, 2023. T. Pachak presented the agenda item. Joan Dizon was present and provided a statement. It was moved and seconded to approve the site survey conducted on December 5, 2023. MOTION PASSED.
- 13. Review, discussion, and possible action for the acceptance of Southeast Career and Technical Academy Nursing Assistant Training Program's submitted remediation plan. T. Pachak presented the agenda item. No representatives were present. It was moved and seconded to approve the submitted remediation plan with a follow-up at the September 2024 board meeting. Review, discussion, and possible action regarding adding to the NSBN CNA Skills Guidelines, with documented competence and training, and at the direction of a licensed nurse, the CNA may perform "the application and removal of female and male external urine collection devices." T. Pachak presented the agenda item. It was moved and seconded to approve the addition to the CNA Skills Guidelines. MOTION PASSED.
- 15. Review, discussion, and possible action related to College of Southern Nevada Practical Nursing program's request to increase maximum enrollment 56 students. M. Johnson presented the agenda item. Dr. Elizabeth Soloman was present and available for questions. Discussion included Senate Bill 375 will be utilized to increase student enrollments, location, will increase in increments, add additional faculty to support the student increase, and the current student/faculty ratio is 1 to 8. It was moved and seconded to grant the student increase to 56 to begin in the Fall of 2025. MOTION PASSED.
