Alston, Karl, CNA030577: Agreement for Reprimand and Continuing Education for violation for NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice.

Anderson, Christopher, RN84715: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(m) action in another state and NAC 632.890 (26) violation of state/federal nursing law/regulation.

Benitez, Kevin, RN 837867: Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice, and (40) committing an error in the administration or delivery of a medication to a patient.

Parker, Christine, CNA 863311: Order for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (9) respondent practiced nursing while, with or without good cause, her physical, mental or emotional condition impairs her ability to act in a manner consistent with established or customary nursing standards, or both and (10) when respondent practiced nursing, if any amount of alcohol or a controlled substance or dangerous drug that is not legally prescribed is present in the body of the nursing assistant as determined by a test of the blood, saliva, breath, hair or urine of the nursing assistant or given while the nursing assistant is on duty.

Perre, Sierra, RN 855413: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice.

Rabadan, Joanna, CNA 847242: Agreement for a Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (2) performing acts beyond the scope of practice of nursing.

Reyna, Johanna, CNA011203: Renewal application denied for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation.
