Arana Sanchez, Aurea, CNA 866942:

Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (20) inaccurate recording, falsifying or otherwise altering or destroying records and (27) customary standards of practice.

Baker, Chelsea, RN93137: Order for Voluntarily Surrender.

DeLa Cruz, Roxana, CNA 855734: Order for Reprimand for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice.

Driscoll, Kimberly, LPN16581: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice.

Faeldonea, Ivy, RN97336: Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (20) inaccurate recording, falsifying or otherwise altering or destroying records, and (28) causing a patient or the family member of a patient physical, mental or emotional harm by taking direct or indirect actions or failing to take appropriate actions.

Fly, Sandra, RN92968: Order for Revocation for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (9) practicing nursing while, with or without good cause, her physical, mental or emotional condition impairs her ability to act in a manner consistent with established or customary nursing standards, or both, and (10) practicing nursing, in any amount of alcohol or a controlled substance or dangerous drug that is not legally prescribed is present in the body of the nurse as

determined by a test of the blood, saliva, breath, hair or urine of the nurse given while the nurse is on duty.

Ganoe, Jodi, RN 851792: Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (18) diverting supplies, equipment or drugs for personal or unauthorized use, and (21) obtaining, possessing, furnishing, or administering prescription drugs to any person, including themselves, except as directed by a person authorized by law to prescribe drugs.

Garibay, Katie, RN78252: Agreement for Reprimand and Continuing Education for violation for NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (2) practice beyond scope and (27) customary standards of practice.

Jose, Roxanne, RN 833535: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (23)(a) offering or giving fees for the referral of a patient.

Lagлива, Janette, LPN12390: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (27) customary standards of practice.

Ramos, Allison, RN 860127: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (20) inaccurate recording, falsifying or otherwise altering or destroying records, and (27) customary standards of practice.

Salazar, Lauren, RN 837547: Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, and NAC 632.890 (2) practice beyond scope, (27) customary standards of practice, and (40) medication error.

Steinmann, Susan, RN44753: RN renewal application for licensure accepted with Agreement for Probation for violation of NRS 632.347 (1)(a) action in another state and (1)(b) criminal conviction.

Sweatt, Yuko, APRN 818074: Agreement for Reprimand, Practice Restrictions, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (26) violation of state/federal nursing law/regulation, and (27) customary standards of practice.
