March 19-20, 2025

The Nevada State Board of Nursing Board Meeting was called to order by Cheryl A. Maes, Ph.D., APRN, FNP-BC, APRN Member, President at 9:00 a.m., on March 19, 2025, at Hilton Garden Inn Las Vegas Strip South, 7830 S. Las Vegas Blvd., Las Vegas, Nevada 89123, and via video and telephonic conferencing.

Call to Order: The meeting was called to order at 9:00 a.m. on Wednesday, March 19, 2025.

Public Comment:

None

A. Board Governance and Administration

- 1. Approval of January 15-16, 2025, Board meeting minutes: The minutes were pulled from the consent agenda. Board member C. Maes and E. De Leon Gamboa disclosed they were not present at the January board meeting and will not be voting. It was moved and seconded the Board approve the January 2025 Board Meeting Minutes with 2 abstentions. MOTION PASSED.
- 2. Review, discussion, and possible action regarding FY 2024/2025 Goals and Objectives: Approved under the Consent Agenda.
- 3. Executive Director Report: C. Dinauer presented an update on the search for a new office location for the Las Vegas staff. She also thanked Board staff for their continuous hard work including assisting with legislative requests, investigations, presentations, and updating the APRN dispensing exam process.
- 4. Review, discussion, and possible action regarding possible revisions to screening question #7: Do you have any condition or impairment (including, but not limited to, substance abuse, alcohol abuse, or a mental, emotional or nervous disorder or condition) which in any way currently affects or limits your ability to practice safely and in a competent and professional manner? C. Dinauer presented this agenda item. It was moved and seconded the Board approve the current language for screening question #7. MOTION PASSED.
- 5. Review and discussion regarding FY 2024-2025 budget to actual through 2nd quarter. C. Dinauer presented this agenda item. K. Neuhauser was present and provided updates regarding the 2nd quarter budget. K. Neuhauser highlighted some notable revenue streams and expenses. Overall, revenue is 5% above budget and expenses are 6% below budget.
- 6. Review and discussion regarding Legislative update. C. Dinauer presented this agenda item. Mike Hillerby was present and provided updates on the 2025 Legislative session including information regarding the following bills:
 - Senate Bill 78 revising provisions relating to boards, commissions, councils and similar bodies:
 - Assembly Bill 363 regarding banning the use of most criminal background checks;
 - Assembly Bill 319 allowing APRNs and RNs to supervise medical assistants;
 - Senate Bill 34 proposing licensure compacts, including the Nurse Licensure Compact;
 - Senate Bill 182 regarding the staffing of healthcare facilities;
 - Senate Bill 249 revising CRNA prescribing abilities;
 - Senate Bill 271 providing funding for a nurse apprentice program.
- 7. Review, discussion, and possible action regarding support for SB 176: Related to education; requiring pupils enrolled in programs of career and technical education for certain professions to take licensure or certification exams and submit the corresponding applications for licensure or certification to receive credit for completing the program; and revising provisions governing fee and age requirements. C. Dinauer presented this agenda item. The Board discussed the barriers students face when applying to take their exams and applying for certification or licensure. The discussion included how the courses are funded for high school students, the requirements for

- certification or licensure, and our current procedures. It was moved and seconded the Board support SB 176. MOTION PASSED.
- 8. Review, discussion, and possible action regarding support for SB 271: Related to making an appropriation to the Division of Public and Behavioral Health of the Department of Health and Human Services for carrying out a nurse apprentice program; and providing other matters properly relating therto. C. Dinauer presented the agenda item. It was moved and seconded the Board support SB 271. MOTION PASSED.
- 9. Review, discussion, and possible action regarding support for AB319 that would allow RNs to delegate to medical assistants. C. Dinauer presented this agenda item. Discussion included the delegation to medical assistants. It was clarified that LPNs are not included in the bill, and our Board does not regulate medical assistants. O. McGuinness stated that she supports APRNs delegating to medical assistants but does not support the bill because it does not include LPNs. It was moved and seconded the Board to support AB 319 with 1 opposed. MOTION PASSED.
- 10. Review and discussion regarding 2nd quarter FY 2024/2025 report for scope of practice trends and questions received by the board. S. McCord presented this agenda item. He began by thanking the discipline team and the investigators for their hard work with investigations and promptly answering scope of practice questions. The second quarter APRN calls were at 59, compared to last year's 37. The most common questions received were regarding patient care, interventions, practice settings with ECT, cardiac interventions collaborative agreements, medication prescribing, and telehealth. The RN calls were at 34, compared to 42 a year ago. Questions received were related to patient care regarding wound care and debridement, educating caregivers in the home, blood pressure assessments on family members, emergency room protocols, and cosmetic procedures. Next, LPN calls were at 18, compared to 19 from last year. The most common questions were regarding IV regulations, IV certifications, requirements of supervision, CPR interventions and general wound care. Lastly, CNAs calls received were at 4, compared to 8 from last year, mostly related to patient care interventions.

S. McCord presented the agenda item. Discussion included hospital administration of IV solutions, IV certification requirement, and LPN relevant practice. It was moved and seconded to accept the revisions as written. MOTION PASSED.
- 2. Review, discussion, and possible action regarding updates and revisions to the Nevada State Board of Nursing Practice Decision titled: The LPN Scope of Practice Regarding Phlebotomy and Blood Sample Collection. S. McCord presented the agenda item. It was moved and seconded to accept the revisions as written. MOTION PASSED.
- 3. Review, discussion, and possible action regarding application for appointment to the CNA and Medication Aide Advisory Committee: Valdez, Kendall, RN94732, iCNA845081; DeYoe, Jama, RN29801, iCNA I0319-0799; Lachowicz, Claudette, RN73429, iCNA I000704. T. Pachak presented the agenda item with 2 open vacancies. It was moved and seconded to appoint Kendall Valdez, RN94732, iCNA845081 and Jama DeYoe, RN29801, iCNA I0319-0799. MOTION PASSED.
- 4. Review, discussion, and possible action regarding application for Board-approved Substance use Disorder Evaluator: Barr, Angella, MD. S. McCord presented the agenda item. It was moved and seconded to accept the application. MOTION PASSED.

C. Education

- 1. Review, discussion, and possible action regarding Carrington College Las Vegas follow-up site visit conducted February 24-25, 2025. M. Johnson presented the agenda. Dr. Nicholas Greene, Dean of Nursing and Dr. Karen Fuss Summer were present and provided statements. It was moved and seconded to approve the site visit, continue to monitor the NCLEX pass rates, implementation and utilization of mountain follow up improvement plan report in six months, and increase full-time faculty to a minimum of 35%. MOTION PASSED.
- 2. Review, discussion, and possible action regarding Las Vegas College's Conditional Approval update report. M. Johnson presented the agenda item. Athena Freeman, Program Chair, was present and provided a statement. Discussion included program instabilities, pass rates, administrative turnovers, and hiring of a nursing consultant. It was moved and seconded to approve the conditional approval update report, require an update of program status and progress in six months at the September 2025 board meeting, and if the NCLEX scores have not stabilized within six months to recommend the program to hire a consultant. MOTION PASSED.
- 3. Review and discussion regarding first-time NCLEX pass rates for 1st quarter 2025. M. Johnson presented the agenda item. Discussion included 1st quarter pass rates, Next Generation NCLEX (NGN) scores balancing out, and repeaters versus first-time testers.
- 4. Review and discussion regarding Credentia CNA Certification Exam 2025 first quarter pass rates. T. Pachak presented the agenda item. Discussion included 1st quarter pass rates, 114 total testers with 86 passing, 22 total programs with 12 programs testing their students, and first-time testers versus repeat testers.
- 5. Review, discussion, and possible action regarding approval of Sierra Nevada Job Corps Nursing Assistant Training Program's biennial site survey findings of October 28, October 30 and December 3, 2024. T. Pachak presented the agenda item. No representative was available. Discussion included pass rates, admission requirements, and site survey. It was moved and seconded that Sierra Nevada Job Corps Nursing Assistant Training Program meets the requirements for ongoing approval, with evaluation of pass rates after 1st quarter 2025 to determine if a remediation plan will be requested. MOTION PASSED.
