B. Old Business:

1. Review and discussed the APRN scope of practice in performing water-jet assisted liposuction and lipotransfer but because there was no quorum will discuss furthermore next meeting.

C. New Business:

1. Cathy Dinauer discussed what took place at the January Board Meeting. An update was given from legislative lobbyist regarding the SB34 bill coming out from the Patient Protection Commission. It's looking to enact 5 compacts which the nursing board is one of those. SB78 is another bill coming from the Department of Business and Industry, the bill consolidates all the occupational boards that bill is still in discussion and will go before the legislature. The Nursing Board approved the practice decision entitled Scope of Practice Requirements and limitations for RNs and LPN Performing Cosmetic Procedures. The board requested more educational opportunities for APRN who proscribe medication. Also, the board requested that LPNs are included in the Particular Practice Decision when it pertains to out of hospital IV administration and IV hydration operations.

Review and discussion related to the Scope of Practice Requirements and Limitations for RNs, LPNs performing Cosmetic Procedures. A. Cormican made a motion to make modifications to the document to finalize and bring to the Board, D. Barisone seconded. Motion carried.

2. Sam McCord presented the quarterly scope of practice trends and questions for 2024/2025

D. Recommendations for Agenda Items for Future Committee Meeting: May 13, 2025. K. Wagner suggested bringing back the FY 2024/25 APRN Discipline Statistics Report for further discussion.
