C. NEW BUSINESS:

1. Review, discussion, and possible action regarding adding the Simulation toolkit to an electronic portal for all programs to access it. M. Johnson presented the agenda item. Discussion included N. 2. Review, discussion, and possible action regarding adding Simulation articles to the Nevada Nursing News Newsletter. M. Johnson presented the agenda item. M. Johnson shared that two programs submitted articles about Simulation to the Nevada Nursing News Newsletter. Also, M. Johnson encouraged the committee to submit articles about Simulation to her for the Fall Newsletter coming out in October 2025.
3. Review, discussion, and possible action regarding potential revision of the Simulation policy. M. Johnson presented the agenda item. M. Johnson led the discussion by sharing the current verbiage of the Simulation policy with a possible revision to how some programs can go to 2:1 versus 1:1. Next, M. Johnson explained how possibly adding criteria regarding if a program is in provisional accreditation, awarded full accreditation, or even possibly an endorsement type of accreditation. Lastly, M. Johnson stated that the goal is to get our programs to obtain accreditation.
4. Review, discussion, and possible action regarding adding Simulation guidelines to NAC 632.685. M. Johnson presented the agenda item. M. Johnson shared that she will be starting up a new committee called the Regulation Committee. Next, M. Johnson explained the purpose of the Regulation Committee is to look over all Education, Nursing, and Simulation regulations for possible revisions.

**PUBLIC COMMENT:**

- Jonlyn Miller was present on behalf of National Nurses Organizing Committee of Nevada and affiliate of National Nevada Nurses united, the largest union and professional organization presenting registered nurses. Miller mentioned that increasing Simulation education in our Nursing programs would unnecessarily replace vital clinical skills, practice on human patients, and ultimately prove detrimental to the development of our new nurses and their practice.
