**Apilado, Patrick, APRN002696:**

Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (27) customary standards of practice, and (42) engaging in any other unprofessional conduct with a patient.

**Benliro, Irene, APRN001014:** Agreement for Reprimand, Practice Restrictions, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, (1)(l) knowingly procured or administered a dangerous drug that is not approved by the United States Food and Drug Administration, NAC 632.890 (26) violation of state/federal nursing law/regulation, (27) customary standards of practice, and (40) medication error.

**Mallory, Trena, CRNA 869169:** Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (18) diverting supplies, equipment or drugs for personal or unauthorized use.

**Mosqueda, Joanne, APRN001986:** Agreement for Reprimand, Practice Restrictions, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, (1)(l) knowingly procured or administered a dangerous drug that is not approved by the United States Food and Drug Administration, NAC 632.890 (26) violation of state/federal nursing law/regulation and (27) customary standards of practice.

**Vega, Diana, RN871047:** Agreement for Probation for violation of NRS 632.347 (1)(g) unprofessional conduct, (1)(l) knowingly procured or administered a dangerous drug that is not approved by the United States Food and Drug Administration, NAC 632.890 (2) performing acts beyond the scope of the practice of nursing, (26) violation of state/federal nursing law/regulation, and (27) customary standards of practice.

**Weir, Brooklyn, LPN 854917:** Agreement for Reprimand and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct, NAC 632.890 (20) inaccurate recording, falsifying, and (27) customary standards of practice.

**Wiesenauer, Amy, RN62138:** Agreement for Reprimand, Fine, and Continuing Education for violation of NRS 632.347 (1)(g) unprofessional conduct and NAC 632.890 (37) practicing without an active license.

**Wong, Bona, CNA021215:** CNA renewal application denied for violation of NRS 632.347 (1)(b) criminal conviction.

**Ygloria, Karyl, RN83130:** Voluntary Surrender of License in Lieu of Other Disciplinary Action for violation of NRS 632.347 (1)(e) controlled substances and/or alcohol, (1)(g) unprofessional conduct, NAC 632.890 (18) diverting equipment or drugs for personal or unauthorized use, and (27) customary standards of practice.
