CALL TO ORDER: The meeting was called to order by Sam McCord at 9:00 a.m.

1. APPROVAL OF MINUTES: November 5, 2024, Pamela Adzima Motioned to approve the minutes as written, H. Church seconded the motion. Motion carried.

B. OLD BUSINESS

1. Reviewed, discussed the scope of practice trends for the first quarter of the fiscal year 2023/2024. The overall number increased compared to the previous year. APRN scope of practice calls received increased. Most common calls were related to population focus. RN scope of practice calls received decreased compared to the previous year. The most common calls received were related to patient care.

C. NEW BUSINESS-

1. Reviewed, discussed the Practice Decision titled: Apprentice Nurse Skill List, to include Administration of IV push or Piggy back by Apprentice RNs. Member Pamela Adzima presented power point titled "IV Med Competency"
2. Reviewed, discussed RN scope of practice related to synchronized cardioversion. C Dinauer stated she did some research on the American Heart Association and ACLS standards. It was discussed that it is appropriate for a ACLS trained RN working Directly with the physician to preform synchronized cardioversion.
3. Cathy Dinauer discussed what took place at the January Board Meeting. An update was given from legislative lobbyist regarding the SB34 bill coming out from the Patient Protection Commission. It's looking to enact 5 compacts which the nursing board is one of those. SB78 is another bill coming from the Department of Business and Industry, the bill consolidates all the occupational boards that bill is still in discussion and will go before the legislature. The Nursing Board approved the practice decision entitled Scope of Practice Requirements and limitations for RNs and LPN Performing Cosmetic Procedures. Sam McCord added that the board requested more educational opportunities for APRN who proscribe medication. Also, the board requested that LPNs are included in the Particular Practice Decision when is pertains to out of hospital IV administration and IV hydration operations.

D. RECOMMENDATIONS FOR AGENDA ITEMS FOR May 6, 2025: C Hintz made a motion to continue to review and discuss the Nurse Apprentice checklist and skills with supervision. P Adzima second. Motioned passed.
